NOTIFICATION

In exercise of the powers conferred by Section 3 of the University Grants Commission Act, 1956, the Central Government, on the advice of the University Grants Commission, hereby declare the K.L.E. Academy of Higher Education and Research, Belgaum (Karnataka) consisting of (i) K.L.E. Society's Jawaharlal Nehru Medical College, Belgaum and (ii) K.L.E. Society's Institute of Dental Sciences, Belgaum as Deemed to be University for the purpose of the aforesaid Act provisionally for a period of five years from the date. K.L.E. Academy of Higher Education and Research stands disaffiliated from the Rajiv Gandhi University of Health Sciences, Bangalore. This is subject to review by a Review Committee to be appointed by the University Grants Commission (UGC). Government of India or the University Grants Commission will not provide any Plan or Non Plan grants to the Academy.
