CLARIFICATION REGARDING FEE STRUCTURE FOR MBBS COURSE ADMITTED UNDER KEA QUOTA AT JGMMMC AT HUBBALLI

The KLE Academy of Higher Education and Research started a new Medical College viz. Jagadguru Gangadhara Mahaswamigalu Moorusavirmath Medical College at Hubballi with annual intake of 150 seats from the academic year 2021-22 with the approval of the National Medical Commission, New Delhi and the Government of Karnataka, Bengaluru. In pursuance of the Agreement signed by the KAHER with the Government of Karnataka, out of 150 seats, 25% seats are to be filled through KEA / Government of Karnataka. The fee structure applicable for these seats has been notified by the Government as -

'These students who are selected under this quota will have to pay 50% of the fees fixed for private quota seats in private colleges as prescribed by the State Government / Fee Fixation Committee from time to time'

As per the fee structure for MBBS course prescribed by the Government of Karnataka for private quota seats in private colleges is Rs.9,94,406/- and hence the fee structure applicable for JGMMMC will be 50% of Rs.9,94,406/- which works out to around Rs.4,97,203/- plus permissible other fees.

A copy of the Notification issued by the Government of Karnataka reg. fee structure applicable for the private quota seats in private colleges is enclosed.

It is once again hereby clarified that the KAHER is charging the fee as per the guidelines issued by the Government of Karnataka.

The Registrar, has applied for affiliation for starting MBBS course afresh with an intake of 150 seats from the academic year 2021-22at Sri Jagadguru Gangadhar Mahaswamigalu Moorusaviramath Medical College (JGMMC), Hubballi, Dharawad vide reference (1) above.

Government of Karnataka has considered the application submitted by the Registrar, KLE Academy of Higher Education and Research (Deemed to be University) and decided to issue the Essentiality Certificate and Feasibility Certificate for starting MBBS

course afresh with an intake of 150 seats from the academic year 2021-22 subject to the following conditions.

- 1) The institution shall give an undertaking in the form of a MoU to the effect that at least 25% of total intake or the percentage of seats that may be determined from time to time as per consensual agreement or as fixed in the Karnataka Professional Educational Institution (Regulation of Admission and Determination of Fee) Act, 2006 shall be surrendered to Government of Karnataka quota without fail.
- 2) These students who are selected under this quota will have to pay 50% of fees fixed for private quota seats in private colleges as prescribed by the State Government/Fee Fixation Committee from time to time.

Therefore, as per Section 10A of the MCI Act, 1956 read with Regulation 3(2) the Medical Council of India (opening of New or Higher Course of Study or Training (including the PG Degree Diploma course of Study or Training) and increase of admission capacity in any course of study or training (including the post graduate course of study or training) Regulation 2000, the Government of Kamataka hereby grant Certificate of Essentiality and Feasibility for starting MBBS course afresh with an intake of 150 (One Hundred and Fifty) seats from the academic year 2021-22 to Sri Jagadguru Gangadhar Mahaswamigalu Moorusaviramath Medical College(JGMMC), Hubballi, Dharawad District in the prescribed format as below:

(4)	Full justification for increasing the intake of MBBS Course:	This College is in the Dharawad District with the population approximately Ten lakhs and has adequate clinical material for medical teaching and clinical facilities. It would cater the medical and health needs of the locals. It possesses the basic infrastructural facilities including teaching hospital and functional hospital to effectively manage and administer the college.

The Registrar, KLE Academy of Higher Education and Research (Deemed to be University) has applied for establishment of Medical College at Hubballi, Dharawad District. On careful consideration of the proposal, the Government of Karnataka has decided to issue an essentiality certificate to Sri Jagadguru Gangadhar Mahaswamigalu Moorusaviramath Medical College (JGMMC) for UG Program afresh with an intake of 150 seats (One Hundred and fifty seats) from the academic year 2021-22.

'It is certified that -

- a) The applicant has entered MoU/Lease with 300 bedded hospital on ownership basis.
- b) It is desirable to establish a medical college in the public interest.
- c) Establishment of a medical College at Hubballi by KAHER is feasible.
- d) Adequate clinical material as per the Medical Council of India norms is available.
- e) Sri Jagadguru Gangadhar Mahaswamigalu Moorusaviramath Medical College (KLE Academy of Higher Education & Research) owns and possesses 23 acres, 32 guntas land Gabbur Cross, Hubballi, Tq: Hubballi, District Dharwad on which non-agricultural use of land is permitted and a Medical College/Hospital can be established on it.
- f) The building plan of the Hospital & Medical College approved by the competent authority viz. Hubli-Dharwad Municipal Corporation.
- g) The Hospital & Medical College have been granted completion certificate/building use certificate by competent authority viz. Hubli Dharwad Municipal Corporation for such purposed on 25-03-2015.

It is further certified that in case the applicant fails to create infrastructure for the course as per NMC norms and fresh admissions are stopped by the Central Government, the State Government shall take the responsibility of the students already admitted in the above said course at this college with the permission of the Central Government.

In continuation the EC & FC is herewith amended as per the new National Medical Council Norms.
