Scheme of Pre Ph.D. Examination

For the Candidates admitted for the year 2020-2021 Batch and onwards

Paper – I & II shall be of 3 Hours duration with 100 marks each.

The pattern of each question paper shall be as follows:

Long Essay Questions:

2 of 20 marks each

= 40 marks

Short Essay Questions:

6 of 10 marks each

= 60 marks

Total:

=100 marks

Paper – I: All the topics covered in the syllabus for orientation programme as described under course work of 300 hours.

Paper – II: The topics related to the research of the candidate.

Paper – III: Bio-statistics shall be of 2 Hours duration with 50 marks.

The pattern of question paper shall be as follows:

Long Essay Questions:

2 of 10 marks each = 2

= 20 marks

Short Essay Questions: 5 of 06 marks each

of OC marks and

= 30 marks

Total: = 50 marks

Note:

- The candidate has to attempt all the questions.
- A candidate has to score minimum of 55% marks for Paper I, II & III each for being declared as pass.
- A Ph. D scholar has to obtain a minimum of 55% or its equivalent grade in the UGC 7points scale (or an equivalent grade/CGPA in a point scale wherever grading system is
 followed) in the course work in order to be eligible to continue the programme and submit
 the thesis.
- If the candidate fails in a paper, he/she has to re-appear only in that paper.
- There will be no practical / viva-voce examination for Pre-Ph.D.
